



## ***Construction Angels Educational Fund***

**SUBMISSION DEADLINE: JULY 12, 2024**

### **Purpose**

Construction Angels, Inc. (CA) is a 501(c)3 Non-Profit charity that provides immediate financial assistance and grief counseling to the children and spouse left behind when a construction worker has a fatality on the jobsite. Construction Angels, Inc. is also accepting applications for the Construction Angels Educational Fund, which provides financial assistance to construction organizations and continuing education institutions within the construction industry. Funds are awarded annually. Applications are available for the 2024 school term of enrollment.

### **Eligibility**

Construction Angels Educational Fund is available within states Construction Angels currently operates that are educating students in construction. Organization, associations, institutions, or continuing education programs are eligible to apply. The CAE Fund is an CA Educational Fund, much like a scholarship, to provide funding to institutions of students in order to attract and retain workers within the construction industry. (Example: Construction Career Days (CCD) provide financial aid programs for students learning about careers and working in the industry while in high school.

### **Educational Institution Requirements**

The applicant must use the funding award to finance the education needs and requirements of the students attending the institution of learning in the construction industry. This could include any public or private: (a) four-year accredited college or university; (b) two-year accredited college; or (c) vocational technical college or construction training institution. Applicants can re-apply each year within the guidelines of construction education.

### **Award Disbursement**

Funding will be awarded once a year and distributed by July 26<sup>th</sup>. Award money will be deposited by the Construction Angels charity directly to the organization or continuing education institutions that is awarded. The funds will go directly to organization or continuing education institution. It is up to the discretion of the organizations and continuing education institutions based on the application presented. CA Education Funds awards are not transferable to another individual or institution and are forfeited by the recipient where the upon failure to utilize the funds as indicated by the application.

### **Application Criteria and Supporting Materials**

All applications need to include the following information. Applications that do not provide all the following information will not be considered.

1. A completed and signed application form. Please take your time completing the application, the Committee appreciate those organizations that take the application process seriously.
2. At least two letters of recommendation in support of the application.
3. A typewritten statement, no more than 500 words, no less than 300 prepared by the organization that explains reasons for requesting funding for educational purposes to educate within the construction industry.  
Note: Selections will be based on the overall worthiness of the applicant by the Committee and will consider all the information provided.
4. A statement providing the approximate cost of the program or need to complete the program.

### **Application Due Date**

Applications must be submitted online by JULY 12, 2024. All applications and supporting materials will become the property of the Construction Angels Educational Fund. I would delete this duplicate info. Above.

### **Scholarship Selection & Notification**

A panel of the Construction Angels Educational Fund/Scholarship Committee will review the information provided and awarded the recipients. Scholarship awards will be made on or before JULY 26, 2024. All applicants will be notified of the results of the Selection Committee in writing.
